



FoxDog Farm 2012 CSAs, Membership Application

The 2012 Summer CSA will run from the week of 28th May to the week of 27th August for a total of 14 weeks. The 2012 Fall CSA will run from the week of 10th September to the week of 12th November for a total of 10 weeks. The two CSAs together run for 24 weeks with a one week break between them.

Summer CSA: Regular shares (2-3 people) are \$315 (\$22.50 a week). Large shares (4-5 people) are \$615 (\$43.93 a week).

Fall CSA: Regular shares are \$225 (\$22.50 a week). Large shares are \$440 (\$44.00 a week).

Both CSAs together: Regular shares \$520 (\$21.67 a week). Large shares \$1020 (\$42.50 a week).

Egg Share Reservations: We offer farm fresh free range eggs, straight from our small flock. Egg shares will be available via reservation, first come – first serve. Those with reservations will be able to pick up 1/2 to 1 dozen eggs a week with their CSA share, and pay monthly or weekly, in advance, for the eggs.

Pick up days are Tuesday (11 am to 3 pm) and Wednesday (3 pm to 7 pm). Please indicate your preference of pick up day below. Pick up is at FoxDog Farm, 26096 Miller Bay Rd. NE, Kingston WA 98346. Note that this is not our mailing address. Please contact us if you will miss a pickup day. If you do not contact us by 8 pm of your missed pickup day, we can't guarantee your share for the week.

We are tentatively offering **delivery of shares** to the Bremerton and Port Orchard areas. This delivery is contingent upon the amount of memberships we receive from each area. We need to have at least 4 memberships in each area to make such delivery feasible (that is 4 in Bremerton for delivery to Bremerton and 4 in Port Orchard for delivery to Port Orchard). We also need a member local to that area to volunteer to host the pick-up place. This volunteer will not have to pay the delivery surcharge. There will be a surcharge for delivery, amounting to, at maximum, 37.50\$ for the Summer CSA and 27\$ for the Fall CSA. This surcharge will be lowered if more than 4 memberships in the southern areas are sold. At this point in time, we are planning delivery on Tuesday afternoons, however these plans may change as we accept new members and work out the details of the delivery schedule.

Remember to contact us via email (farmer@foxdogfarm.com) or phone (360 297 7135) before you send in this application and your fees. CSA memberships are limited, so we need to be sure we have space.
