

# FoxDog 2010 CSAs

## *Incremental Payment Plan*

The amount due each month depends upon when you start the payment plan. The Summer CSA must be fully paid for by the time the Summer CSA starts. **The last payment for the Summer CSA is therefore due by 19<sup>th</sup> May, 2010.** The Fall CSA must be fully paid for by the time Fall CSA planting begins. Therefore **the last payment for the Fall CSA is due by Friday, 16<sup>th</sup> July 2010.**

### Instructions:

1. Decide if you want to join both CSAs or only one CSA. Find the appropriate payment schedule for the size of share you want in the tables below.
2. Find the month you wish to start payment and find the amount due that month. For instance if you are joining both CSAs and you wish to purchase a regular share and start payment in February, you will owe \$81 in February and \$80 after that until July. If you wish to start payment in March you will owe \$96.20 until July and so on.
3. Note that payments for some share sizes vary slightly per month.
4. Check off, sign and date the agreement at the end of this document, as well as the main CSA agreement, and send both of them, along with your first payment to

5. Send subsequent payments, each month, to the above address. We will email you an invoice in return, showing your total amount paid and total amount due.
6. Payment is due in full for the Summer CSA by 19<sup>th</sup> May 2010, and for the Fall CSA by 18<sup>th</sup> July 2010.

I understand that if I have not paid in full by the final payment dates of 19<sup>th</sup> May 2010 for the Summer CSA and 16<sup>th</sup> July 2010 for the Fall CSA I may lose my place in the CSA for that season with no refund available. By signing below I, the purchaser, agree to be bound by these terms.

If personal disaster strikes, FoxDog Farm, the seller, will make every attempt to be fair and equitable in any refunds available to the purchaser. However, please remember that FoxDog Farm will have already bought the supplies for the purchaser's share, and in most cases will have already started the purchaser's vegetables growing. If another person or family can not be found to take the purchaser's place in the 2010 CSA for the season or seasons concerned, FoxDog Farm will not be able to issue a refund.
